



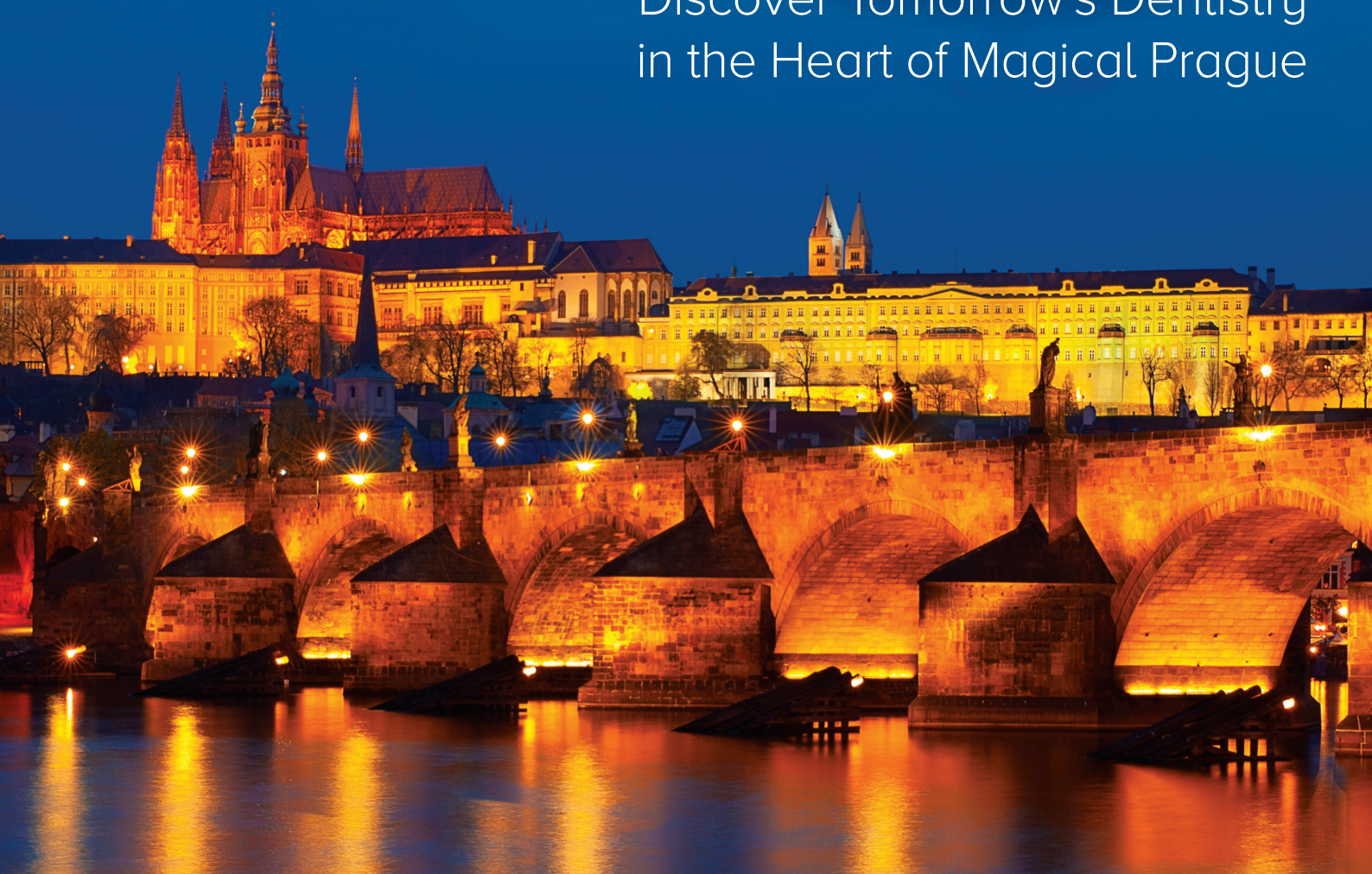

## HOW TO REGISTER

To register for the Congress, please fill in the on-line Registration Form available on the website of the congress.

**For group registration** (more than 5 participants), please contact the FDI Congress Secretariat at [fdiwdc2026@guarant.cz](mailto:fdiwdc2026@guarant.cz)

Each delegate within the group will be eligible for a discount.

*For groups of 5-9 participants, a 5% discount will apply.*

*For groups of 10+ participants, a 10% discount will apply.*

## METHODS OF PAYMENT

Registration fees must be paid in EUR by one of the following methods:

**1. Credit or Debit Card** (preferred option)

**2. Bank Transfer**

Please note that bank transfer payments will only be accepted by 31 August 2026.

In case of any change in registration, GUARANT International reserves the right to charge a 20 EUR handling fee.

In the event that a visa application is rejected, the participant is entitled to a refund of the registration fee upon submission of official proof of the visa denial.

### Name change

If you are prevented from attending, you will be given the opportunity to send a colleague in your place. A handling fee of 20 EUR will be charged for each name change. Name changes should be reported in writing to FDI Congress Secretariat at [fdiwdc2026@guarant.cz](mailto:fdiwdc2026@guarant.cz).

## VISA REQUIREMENTS

Please note that invitation letters for visa purposes can only be issued to people who have completed the registration process and paid the registration fee.

**Visitors from non-EU countries** must possess a passport valid for **at least three months** after the planned departure from the Czech Republic. Please note that **the visa application process can take up to 6 weeks**. Therefore, the participants requiring visa should apply immediately to the consular office or embassy of the Czech Republic in their home country in order to avoid any inconvenience.
